Dear CFC Board and CFC Executive Director

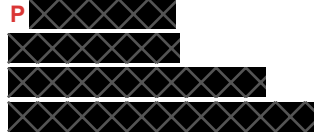

Dear CFC Board and CFC Executive Director

I propose that the “restoration meeting” of the committee on December 10, be canceled for the following reasons:

Firstly, this meeting to address the “restoration committee was set up by Tim Harrison and his team without the knowledge and authorization of the Board of CFC.

Secondly, the selection of the restoration committee has not been completed, neither have they been approved or appointed by CFC board as yet. Therefore, addressing only some of the proposed members of the “restoration committee” when the rest have not yet been selected and approved is premature and out of order.

Thirdly, Tim Harrison and his band of followers have just attempted one of the most deceptive, trickiest and hostile spiritual assassinations of a Founder and President of a ministry in the USA, through a written letter signed by Denise La Rocco, Tim Harrison and Scott Sullenberger, initiating the unauthorized and illegal process of church discipline of their CFC President.

Fourthly, Tim Harrison and his band of followers have just attempted to remove the ministry of CFC from Steven Koko and give it to Tim Harrison.

Fifthly, in addition to deceiving the board of CFC, Tim Harrison added insult to injury by plotting to fire the present CFC board of Steve Theofanus and Joseph Slone and to establish his own.

Sixthly, Tim Harrison forbid Koko and CFC team members to communicate with each other under the guise that he is protecting them from Koko. But that isn't true. Tim Harrison was deliberately isolating CFC members from Koko because he wanted to manipulate and

control this entire narrative to the point when CFC members were starting to ask uncomfortable questions, they cancelled the Wednesday prayer meetings to prevent the truth from coming out.

The seventh reason to cancel December 10 and not give him a platform is that Tim Harrison repeatedly claimed that a voice spoke to him a few months ago saying “Tim Harrison CFC belongs to you. You will replace Koko” (to the best of my recollection as told by Tim to me personally).

The eighth reason to cancel December 10, is that Tim Harrison has demonstrated over and over again that he and his followers do not have the best interest of Koko and CFC at heart. Instead their intention is to harm Koko and CFC ministries. One way Tim did this was to tell the CFC team that when he addressed Koko on Sunday November 20, and I quote, “I was not speaking to Steven Koko, I was speaking to a demon. And that demon in Koko is the highest level of the Jezebel spirit.”

The ninth reason is that the information Tim Harrison wants to share with the “restoration committee” he has heard directly from Koko. In the light thereof, the CFC board do not need to hear a second-hand version from Tim Harrison if they can hear the original version from Koko himself.

Finally, this betrayal and assassination of Koko and CFC was made possible by Denise La Rocco. She tricked the rest of her fellow board members to vote to appoint Tim Harrison. The board voted in favor of appointing Tim as CFC Interim President, believing Steven Koko has asked to go on a sabbatical.

But the board was fooled and betrayed by Denise La Rocco. She deliberately and intentionally set out to deceive the CFC board in order to pave the way for Tim and his executive board to place Koko under church discipline and **START THE RESTORATION PROCESS!** Denise already knew about the letter of discipline Tim wrote on November 16 and she aided and abetted Tim Harrison by arranging the CFC Board Meeting on November 20, got him appointed for the **SOLE PURPOSE** to execute Koko and take CFC for himself and his followers.

In the light of the above facts, I propose that:

1. December 10 “restoration committee” meeting arranged by Tim Harrison without the knowledge and authorization of CFC be **CANCELLED**. Instead allow Tim Harrison to write a letter to CFC board expressing and explaining himself as much as he wants.
1. Tim Harrison be removed as Interim President of CFC on the grounds of deception. No Vote is needed here. And if a vote is proposed then Denise La Rocco is not entitled to vote in the matter because of the role she played in orchestrating the betrayal and deception.

1. Again In this entire matter of Tim Harrison, Denise La Rocco is not allowed to vote because she disqualified herself on the grounds of deception. Her vote in a matter in which she is guilty, constitutes a CONFLICT OF INTEREST. In the same way Koko cannot vote in a matter where he is involved.

1. Scott Sullenberger's membership of CFC Ministries be terminated with immediate effect and that he gets instructed to return all CFC property to the ministry and that he ceases to make contact with CFC members for the entire period of Koko's
