I'll keep this short as I've said all I needed to in my previous 3 letters. I have stated more than once that I will present my information and recommendations to the board and then trust them with their legal right for their decisions. Allow me to sum it up in one page.

- I asked for an investigation into donor funds (mine included) where airbnbs and possibly flights were booked that resulted in the mental, physical, and possible sexual abuse of women.
- I presented that Solomon, Maria and Koko are lying about many things and developed a false
 narrative that has taken honest attempts to help CFC and Steven Koko and sown strong mistrust
 and division. Either I'm giving false accusations and should be called out on them or they are.
 Neutral or non action is sweeping things under the rug.
- The cease and desist was a desperate move to continue to silence anyone who wanted to question the integrity of CFC and its founder. The only thing I signed stated that my confidentiality was regarding any new details on the December 10th meeting (as per my amendment that was read in front of all present). I have kept to that, but was also informed when I asked for my letter so my lawyer could review that it has been lost. You know that I could simply post whatever I want (even the videos I have access to) and let the people decide whether or not to trust Koko and Solomon and their ministries again. But I won't. God will vindicate what He wants and bring justice where he wants. That's not my role.
- I stated that I don't want a dime of CFC money. I'm told some staff may get severance. You can't send me any as you don't know where I live:) I'll state again, I don't want money. Please put any potential severance of mine towards a good cause if you must like a home for abused women, but not one that CFC has any involvement in now or or plans to in the future.
- Since my trust is low that these funds will be used as the board agrees, my resignation as acting
 president will be official once that money is received by every person and place that is decided
 upon today. Not before. I still have a legal standing in CFC based on Steven Kokos
 announcement to the team in Mexico on the November retreat and the board vote that was never
 recalled.
- I presented my reasons for why it is crazy to allow the abuser to make decisions about the future of this ministry and to control a narrative that covers the truth at the danger of more harm to women and others. As I understand that you are choosing to allow the ministry to be more important than the marginalized or than integrity before heaven, I will personally only refer to CFC as CFK in the future. If someone asks why I will only tell them to ask you themselves.

CFC has become one of the ministries that has always disgusted me. I was introduced to it in 2015 and it had its issues but also had the fear of God. I don't see that same fear today and am concerned. I called for righteousness, integrity, and transparency on all sides. I was here to help and to hold a standard. I have been tarnished, silenced, and ignored. I am not bitter. I hold no offense towards any individual but my position before the Lord remains. I stand with the ministry of Jesus and not some perverse Americanized version of it.
